#### Using the Bakersfield Sunland Refinery Case as an Example

*Deputy District Attorney John Mitchell is assigned to the civil unit of the Kern County District Attorney's Office, and prosecutes consumer fraud and environmental cases. In 1995, he prosecuted World Oil for the explosion at the Sunland Refinery that caused the death of Tracy Kildebeck and injured several others. The case resulted in a \$5.5 million civil settlement and an injunction against World Oil. Since then, DDA Mitchell has prosecuted over a hundred civil cases, many of which involved safety threats to workers and the public. He will explain the types of cases that his office prosecutes and the sorts of resolutions that they seek to obtain.*







The Division of Occupational Safety and Health proposes to make permanent the emergency regulations that the Office of Administrative Law (“OAL”) approved on or about November 1, 2018, amending sections 14300.35 and 14300.41 of the California Code of Regulations, Title 8, to require designated employers in California to submit electronically certain occupational injury and illness information to the federal Occupational Safety and Health Administration (“OSHA”). (See OAL Rulemaking File No. 2018-1025-02E.) A public hearing has been scheduled to permit all interested persons the opportunity to present statements or arguments on the proposed amendments:

### **OSHA Requests Information on Possible Updates to the Lockout/Tagout Standard**

WASHINGTON, DC – The U.S. Department of Labor’s Occupational Safety and Health Administration (OSHA) is requesting information on a possible update to the Control of Hazardous Energy (Lockout/Tagout (LOTO)) standard. The Agency is interested in comments on the use of control circuit-type devices to isolate energy, as well as the evolving technology for robotics.

OSHA is requesting information about how employers have been using control circuit devices, including information about the types of circuitry and safety procedures being used; limitations of their use, to determine under what other conditions control circuit-type devices could be used safely; new risks of worker exposure to hazardous energy as a result of increased interaction with robots; and whether the agency should consider changes to the LOTO standard that would address these new risks.

The current LOTO standard, published in 1989, requires that all sources of energy be controlled during servicing and maintenance of machines and equipment using an energy-isolating device. The standard specifies that control circuit devices cannot be used as energy-isolating devices, but the agency recognizes recent technological advances may have improved the safety of control circuit-type devices.

Comments must be submitted on or before August 18, 2019. Comments and materials may be submitted electronically at <http://www.regulations.gov>, the Federal e-Rulemaking Portal, or by facsimile or mail. See the [Federal Register notice](#) for submission details.

Under the Occupational Safety and Health Act of 1970, employers are responsible for providing safe and healthful workplaces for their employees. OSHA’s role is to help ensure these conditions for America’s working men and women by setting and enforcing standards, and providing training, education and assistance. The BCSP pursues cases of individuals claiming to hold our credentials without permission. They pursue those cases in which there is clear evidence of the unauthorized use and the individual has a clear responsibility, control, or knowledge of the use. Evidence may be a business card, resume, letter, website, or other publication. If there is no clear evidence, BCSP cannot act on the case.


