## **U.S. Department of Labor Reminds Employers About Submitting Injury and Illness Data to OSHA**

WASHINGTON, DC – The U.S. Department of Labor’s Occupational Safety and Health Administration (OSHA) is reminding employers who have not already done so to submit their 2018 OSHA Form 300A (Summary of Work-Related Injuries and Illnesses).

### **Who is required to submit Form 300A?**

- ⇒ Establishments with 250 or more employees that are required to keep OSHA injury and illness records, and
- ⇒ Establishments with 20 to 249 employees in certain industries. For the list of designated industries, visit <https://www.osha.gov/laws-regs/regulations/standardnumber/1904/1904.41AppA>.

### **How to submit Form 300A:**

Submit injury and illness data electronically at [www.osha.gov/300A](http://www.osha.gov/300A).

For questions about submission requirements, complete the Help Request Form at [www.osha.gov/injuryreporting/ita/help-request-form](http://www.osha.gov/injuryreporting/ita/help-request-form).

Under the Occupational Safety and Health Act of 1970, employers are responsible for providing safe and healthful workplaces for their employees. OSHA’s role is to help ensure these conditions for America’s working men and women by setting and enforcing standards, and providing training, education and assistance. ## **ASSP Supports Reopening OSHA's Lockout/Tagout Rulemaking**

**August 15, 2019**

ASSP has submitted a [technical comment](#) and a letter of support in response to OSHA's [request for information](#) on the [control of hazardous energy \(lockout/tagout\)](#). Drafted by the ANSI/ASSP Z244 Committee, the comment calls on OSHA to reopen the current federal regulation so it can be revised to better reflect the modern technology used in lockout/tagout. The original regulation was written in 1982, and it does not address alternative methods of lockout/tagout that have developed since the regulation's inception.

## **ASSP Committee Proposes Heat Stress Management Standard**

At its recent meeting in Washington, DC, the ANSI/ASSP A10 Committee took the first step in creating a document that will identify industry best practices for properly managing heat stress for workers involved in construction and demolition. The proposed American National Standard under ANSI, BSR/ASSP A10.50, will establish minimum requirements for the prevention of heat illnesses and management of heat stress hazards and exposures encountered during construction and demolition.

“There are tens of thousands of heat-related illnesses that impact the construction and demolition workforce each year and unfortunately, construction workers are still dying from exposures to excessive heat,” says John Johnson, chair of the ANSI/ASSP A10 Committee. “The proposed A10.50 standard will provide the industry with proven solutions to avoid heat illnesses that impact the construction and demolition workforce.”

Currently, there is no federal OSHA standard or voluntary consensus standard which addresses the issue of heat stress, although many groups have requested guidance on best practices. The A10 committee hopes that the creation of such a document helps employers develop effective heat stress policies and procedures.

## New Cal/OSHA Chief



After months of the occupational safety and health community waiting, Governor Gavin Newsom has finally named a new Cal/OSHA Chief. Douglas Parker is his name. Parker, 50, has been the executive director of the Oakland worker advocacy group Worksafe since 2016.

Parker is an attorney and has a long resume in democrat politics, and more recently, occupational safety and health. He is a former assistant to the late Minnesota senator Paul Wellstone, then worked in press operations for the Democratic National Committee before and during the Clinton administration. He was a staff attorney for the United Mine Workers of America in the late 1990s, and during most of the 2000s was a partner at the Mooney, Green, Baker & Saindon law firm.

Starting in 2009, he was named a senior policy advisor and special assistant at the Mine Safety and Health Administration and served as assistant secretary of labor for MSHA from 2014 to 2015. Parker attended the University of Virginia School of Law. He was admitted to the California bar in 2016.

He replaces Juliann Sum, who retired earlier this year. He beat out two strong internal candidates, including Process Safety Management Unit manager Clyde Trombetta, and Deputy Chief for Enforcement Debra Lee. The appointment requires Senate confirmation.

## **What is the time commitment?**

This year RAMP will be an academic-year-long program, running from September 2019 to May 2020. We ask mentors and mentees to meet at least once a month and attend at least two of our events.

But mentors and mentees can meet up as often as they'd like and any way they'd like, whether in person or by phone, text or email.

## **What happens after a mentor or mentee applies?**

For 2019-2020, mentor committee members will conduct a short phone interview of applicants through early September. By mid-September we will notify all applicants (by email) whether they've been accepted and invite them to a kickoff event in late September where mentors and mentees can meet. Any mentors or mentees who cannot attend will receive an email with the name of and contact information for their counterpart. We prefer that mentees make first contact with mentors, just as job applicants must take initiative when competing in the job market. 

3. Identify how creating employee buy-in also helps create a culture of accountability across the organization


### **Speaker: Catherine Jones, CSP, ARM - Associate Professor, Bakersfield College**

**Topic: Can You Hear Me Now? Noise Hazards In The Workplace**



Occupational noise induced hearing loss is preventable, but is unfortunately among the most common work related illnesses throughout all industries. According to the National Institute of Occupational Safety and Health (NIOSH), approximately 17% of the US work force (22 million) are exposed to hazardous noise and 19% (4.2 million) of these noise exposed workers have hearing loss. By knowing how to properly recognize, evaluate and control occupational noise, we can prevent occupational noise induced hearing loss for our workers. Learning Objectives:

1. Examine the anatomy and physiology of hearing and the physics of sound
2. Identify various types of hearing loss
3. Review methods to recognize and evaluate noise hazards
4. Examine practical noise control solutions



**Topic: Hazardous Waste**




