# ASSP Supports Reopening OSHA's Lockout/Tagout Rulemaking August 15, 2019

Hopefully you have seen that OSHA is considering reopening its lockout/tagout rule, which could impact all occupational safety and health professionals (OSH) in the U.S. ASSP and the ANSI/ASSP Z244 Committee (Control of Hazardous Energy – LOTO) submitted a very detailed technical comment addressing LOTO and the issues of alternative approaches to LOTO. We hope you review the comments since this potentially could have an impact on all OSH Professionals. Without trying to sound overly dramatic, this very well could be the most detailed technical comment ASSP has ever submitted on a regulatory issue. All of you do, or will, address hazards and exposures with LOTO in your OSH career and this is a significant issue for many members.

ASSP hosted webinar on this issue on September 17th, examining current consensus thinking on the control of hazardous energy and possible scenarios involving a reopened OSHA rule. The ANSI/ASSP Z244.1 Standard presents requirements for controlling hazardous energy through three different approaches: lockout (the primary approach), tagout and alternative methods. ASSP reviewed the standard's requirements with focus on the use of control systems as used in alternative methods. In addition, ASSP discussed situations that may require alternative methods rather than conventional lockout and reviewed criteria for evaluating alternative methods based on risk assessment and determining their effectiveness.

#### U.S. Department of Labor Approves New Respirator Fit Testing Protocols to Protect Workers from Airborne Contaminants

WASHINGTON, DC – The U.S. Department of Labor's Occupational Safety and Health Administration (OSHA) today issued a final rule that provides employers with two new fit testing protocols for ensuring that employees' respirators fit properly.

The new protocols are the modified ambient aerosol condensation nuclei counter (CNC) quantitative fit testing protocol for full-facepiece and half-mask elastomeric respirators, and the modified ambient aerosol CNC quantitative fit testing protocol for filtering facepiece respirators. Both protocols are variations of the original OSHA-approved ambient aerosol CNC protocol, but have fewer test exercises, shorter exercise duration, and a more streamlined sampling sequence.

These two quantitative methods add to the four existing in <u>Appendix A</u> of OSHA's Respiratory Protection Standard, which contains mandatory respirator fit-testing protocols that employers must choose from to protect employees from hazardous airborne contaminants. The rule does not require employers in general industries, shipyard employment, and construction to update or replace their current fit testing methods, and does not impose additional costs.

The rule becomes effective September 26, 2019.

#### What is the time commitment?

This year RAMP will be an academic-year-long program, running from September 2019 to May 2020. We ask mentors and mentees to meet at least once a month and attend at least two of our events.

But mentors and mentees can meet up as often as they'd like and any way they'd like, whether in person or by phone, text or email.

#### What happens after a mentor or mentee applies?

For 2019-2020, mentor committee members will conduct a short phone interview of applicants through early September. By mid-September we will notify all applicants (by email) whether they've been accepted and invite them to a kickoff event in late September where mentors and mentees can meet. Any mentors or mentees who cannot attend will receive an email with the name of and contact information for their counterpart. We prefer that mentees make first contact with mentors, just as job applicants must take initiative when competing in the job market. **Topic: Does Safety Really Matter?** 



Does Safety Really Matter? The question is meant to provoke the thought that perhaps safety represents different things to different people and that the value of safety changes depending upon context and perspective. This session is meant to present safety as a value, instead of a compliance option. Learning Objectives:

- 1. Identify the primary reasons accidents happen in a simplified framework.
- 2. Discuss the value of safety through a focused lens where differing values can foster individual buy-in.
- 3. Identify how creating employee buy-in also helps create a culture of accountability across the organization

#### Topic: Can You Hear Me Now? Noise Hazards In The Workplace



Occupational noise induced hearing loss is preventable, but is unfortunately among the most common work related illnesses throughout all industries. According to the National Institute of Occupational Safety and Health (NIOSH), approximately 17% of the US work force (22 million) are exposed to hazardous noise and 19% (4.2 million) of these noise exposed workers have hearing loss. By knowing how to properly recognize, evaluate and control occupational noise, we can prevent occupational noise induced hearing loss for our workers. Learning Objectives:

- 1. Examine the anatomy and physiology of hearing and the physics of sound
- 2. Identify various types of hearing loss
- 3. Review methods to recognize and evaluate noise hazards
- 4. Examine practical noise control solutions
