

The constant news about COVID-19 have been depressing, with vignettes of many stories of heroes in our healthcare, first responders, teachers, and many other our public servants. What is rarely heard is the story of those that are behind the scenes, our *custodial services workers*, the demand they have burden, the unknown the inherited, and the misinformation they have hear. In many parts of our country custodial operations are **predominantly staffed by a Hispanics workforce, most of them immigrants with a language barrier**, and know they are part of our country's frontline fighting the spread of COVID-19.



Emergency Showers and Eyewashes

This presentation will be centered on the 2014 version of the ANSI/ISEA Z358.1 Standard for Emergency Showers and Eyewashes. Other applicable codes, regulations and standards will be discussed including – Cal Plumbing Code (Became Effective Jan 1, 2020), Cal OSHA Title 8 Section 5162, and ASSE 1071 Std for Temperature Mixing Valves for plumbed eyewash and showers. There will be an emphasis on regional sectors including: Aerospace, Ag, Education, Healthcare, Petro-Chemical, and Water Treatment Plants.



The meeting will be hosted virtually. Details to be sent out via email at a later date.
