Emergency Showers & Eyewashes

This presentation will be centered on the 2014 version of the ANSI/ISEA Z358.1 Standard for Emergency Showers and Eyewashes. Other applicable codes, regulations and standards will be discussed including – Cal Plumbing Code (Became Effective Jan 1, 2020), Cal OSHA Tile 8 Section 5162, and ASSE 1071 Std for Temperature Mixing Valves for plumbed eyewash and showers. 

Also, students interested or enrolled in bachelor's degree programs such as CSUB or Columbia Southern can transfer BC units which helps keep the cost of the degree manageable (approx. \$47 per unit compared to over \$200 per unit).
