Electrical Inspections for the Safety Professional

This presentation includes a quick introduction to NFPA 70E, PPE requirements, designing for safe use, and emergency response.

Risk Management – Enabling Risk-Based Decisions by Looking at the Big Picture

First priority, right? Guess again. In fact, that thinking is not only a fallacy, but a business sustainability death wish. Understanding where your department's risk sits at an enterprise level will gain you credibility and efficiency while allowing a more formidable foundation for a progressive and SUSTAINABLE safety culture.




