Risk Management – Enabling Risk-Based Decisions by Looking at the Big Picture

This presentation is intended to challenge the way the safety practitioner looks at risk by looking at risk from an enterprise level and understanding where health, safety, and environmental risks fall in priority. First priority, right? Guess again. In fact, that thinking is not only a fallacy, but a business sustainability death wish. Understanding where your department's risk sits at an enterprise level will gain you credibility and efficiency while allowing a more formidable foundation for a progressive and SUSTAINABLE safety culture.

Learning Objectives – 1) Learn how to leverage the inherent risk management skill in all of us. 2) Learn to see the big picture of organizational risk and reduce tendencies of being "safety-selfish." 3) Walk away knowing what needs to be done to understand where YOUR risks fall into the organization's priority list; when to fight, and when to settle.

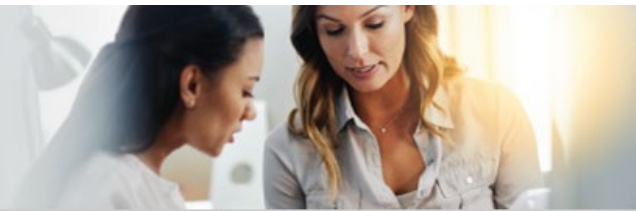

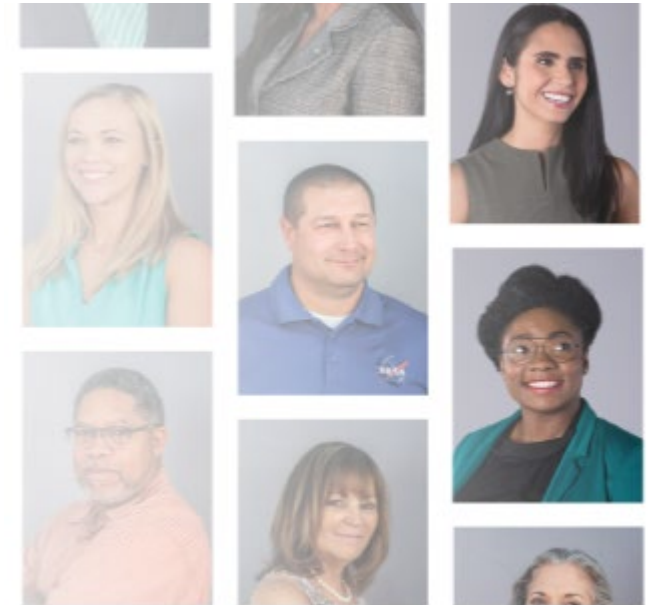

Susan Harwood Training Grants

The [U.S. Department of Labor](#) announced a funding opportunity for \$11.7 million in [Susan Harwood Training Grants](#) to support the delivery of training and education to help workers and employers identify and prevent workplace safety and health hazards.

Administered by the department's [Occupational Safety and Health Administration](#), the grants will target disadvantaged, underserved, low-income, and other hard-to-reach, at-risk workers and employers. The grants are available to non-profit organizations, including community-based, faith-based, grassroots organizations, employer associations, labor unions, joint labor/management associations, Indian tribes, and public/state colleges and universities.

Submit applications no later than 11:59 p.m. EDT on Aug. 1, 2022. Applicants must register with [grants.gov](#) and the System of Award Management to apply.

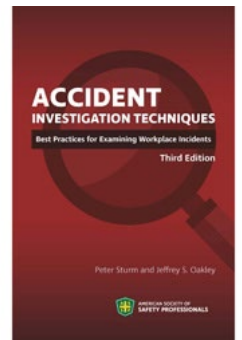

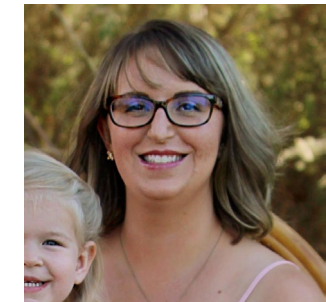
