Being Prepared for a Community in Crisis (YES There is reason to be a "Prepper")

This presentation will discuss probable events that have the capacity to cause Kern County's community to be in crisis mode. Coupled with that, this presentation will discuss "needs" that one should understand to prepare their family to survive an event that caused their community to be in crises. Most important are the three basics: Water, Food, Shelter. This discussion will also touch on the following "Prepper" topics:

- 1) Water (personal needs, hygiene needs, preserving water, etc.)
- 2) Food (growing, gathering, preservation and storage)
- 3) Non-food emergency stores (shelter, fuel storage, hygiene, meds, etc.)
- 4) Alternative power sources (lights, batteries, etc.)
- 5) Communication (knowing what is going on, letting family know status)
- 6) DIY Medicine
- 7) Personal Safety (Shelter-in-place vs Bug-out)
- 8) When on-the-run becomes your best option

- ➤ <u>Updated A10.39 Standard Published</u> The ANSI/ASSP A10.39-2022 Construction Safety and Health Audit Program standard establishes an internal method of measuring compliance with an organization's written safety and health program requirements.
