July 3, 2024 Chapter Meeting

Joseph Valenzuela, Operations Manager - Pathfinder Optics Corporation

Leveraging Technology to Mitigate the Risks of Mitigating EHS Risk by Using Robotics Technology

This presentation will include an overview of how robotics technology can improve EHS in industries such as water management, agriculture, electrical operations, industrial applications, forestry management, and traditional and renewable energy sectors. Mr. Valenzuela will offer insights for EHS professionals seeking to leverage robotics to inspect critical or difficult-to-access areas utilizing drones and crawlers (inside piping). He will also discuss submersibles to inspect/monitor infrastructure such as dams, bridges, pipelines, marine environments, and ecosystems. Hazardous environment applications will be highlighted where robotics effectively mitigate risks including confined spaces (e.g., tanks, vessels, vaults, underground sewer, and storm drain systems), wind turbines (e.g., Internal Blades), Solar Field and Overhead Power Line Inspections.

Gun Safety

Randall Meyer and Joey Mier will include the following topics during this presentation: Carrying a Concealed Weapon (CCW) issuing requirements; Civil and criminal liabilities to consider when using a firearm for self-defense; Safe storage of firearms and the law; Safely transporting a firearm; and the law regarding bringing firearms into the state (if someone has moved from another state); and recently enacted laws.

Randall Meyer has been in law enforcement for over 20 years. While working in law enforcement, he has worked full time as an assistant range master. He spent 10 years on the SWAT team, 7 of those as a sniper. He started Advanced Personal Protection in 2011, focusing on preparing people to carry a gun safely in public and surviving deadly force encounters.

Joey Mier attended the California POST academy and has certifications in Level 3 and Level 2. Joey has attended multiple other classes and carries the following certifications: NRA Pistol, Rifle and Shotgun Instructor, Range Safety and Development Certification. He also holds certifications in DOJ Firearms Instructor and DOJ Firearm Safety Certificate Instructor.

STANDARDSUPDATE

- Fleet/Motor Vehicles (Z15) Motor vehicle crashes are the leading cause of work-related deaths in the U.S. Addressing this hazard requires a structured, proactive approach to identify system gaps and implement industry best practices. The ANSI/ASSP Z15.1 standard can guide an organization's effort to develop policies, procedures and management processes to control risks associated with the operation of motor vehicles.
- ➤ <u>Hydrogen Sulfide Training (Z390.1)</u> The ANSI/ASSP Z390.1 standard establishes minimum requirements for site-specific hydrogen sulfide safety training programs that will enhance safety in occupational settings where hydrogen sulfide is present or is recognized as being potentially present.
- ➤ <u>Walking/Working Surfaces (A1264)</u> The ANSI/ASSP A1264 standards aim to protect people who work in industrial & workplace settings that present the hazard of people or objects falling from elevated walking & work surfaces such as floor, roof or wall openings, platforms, runways, ramps, fixed stairs or roofs in normal, temporary, and emergency conditions.

Important Information on ASSP Membership

ASSP have some important news to share about how your ASSP membership will soon deliver even greater value to support your career growth and success and elevate the entire occupational safety and health (OSH) profession.

What's Changing?

Access to all our practice specialty and common interest group member communities will be included as part of your annual dues, meaning you will no longer be required to pay a separate fee to participate in them. For full members, dues will increase to \$215 USD over a three-year period as follows – \$195 for the first year, \$205 for the second year, and \$215 for the third year.
