#### Randall Meyer & Joey Mier Advanced Personal Protection, LLC GUN SAFETY

Randall Meyer and Joey Mier will include the following topics during this presentation:

Carrying a Concealed Weapon (CCW) issuing requirements; Civil and criminal liabilities to consider when using a firearm for self-defense; Safe storage of firearms and the law; Safely transporting a firearm; and the law regarding bringing firearms into the state (if someone has moved from another state); and recently enacted laws.

Randall Meyer has been in law enforcement for over 20 years. While working in law enforcement, he has worked full time as an assistant range master. He spent 10 years on the SWAT team, 7 of those as a sniper. He started Advanced Personal Protection in 2011, focusing on preparing people to carry a gun safely in public and surviving deadly force encounters. Joey Mier attended the California POST academy and has certifications in Level 3 and Level 2. Joey has attended multiple other classes and carries the following certifications: NRA Pistol, Rifle and Shotgun Instructor, Range Safety and Development Certification. 

#### Lead-Volution 2025 - Redefining CA Lead Safety Standards a.k.a Revised Lead Standard

#### **Indoor Heat Requirements**

On June 20, 2024, the Occupational Safety and Health Standards Board approved California Code of Regulations, <u>Title 8</u>, <u>Section 3396</u>, "Heat Illness Prevention in Indoor Places of Employment". This standard applies to most workplaces where the indoor temperature reaches 82°F. It establishes required safety measures for indoor workplaces to prevent worker exposure to risk of heat illness. This standard went into effect on July 23, 2024.

# Standards and Resources

## **STANDARDS**UPDATE

- Fleet/Motor Vehicles (Z15) Motor vehicle crashes are the leading cause of work-related deaths in the U.S. Addressing this hazard requires a structured, proactive approach to identify system gaps and implement industry best practices. The ANSI/ASSP Z15.1 standard can guide an organization's effort to develop policies, procedures and management processes to control risks associated with the operation of motor vehicles.
- ➤ <u>Hydrogen Sulfide Training (Z390.1)</u> The ANSI/ASSP Z390.1 standard establishes minimum requirements for site-specific hydrogen sulfide safety training programs that will enhance safety in occupational settings where hydrogen sulfide is present or is recognized as being potentially present.
- ➤ <u>Walking/Working Surfaces (A1264)</u> The ANSI/ASSP A1264 standards aim to protect people who work in industrial & workplace settings that present the hazard of people or objects falling from elevated walking & work surfaces such as floor, roof or wall openings, platforms, runways, ramps, fixed stairs or roofs in normal, temporary, and emergency conditions.
